Minutes of KSKA General Assembly

A1: Welcome

Since the President was not present, Pascal Petrella from the Shihankai took the chair of the meeting.

Pascal Petrella welcomed the KSKA members to the general assembly in Plouay. He excused the President Dirk Heene and Vice-President Jim Martin. Due to important personal reasons they were unable to attend the GA.

Mr. Petrella stated that regarding the statutes, the GA was called in correctly.

A2: Identification of presence and verification of entitled voters

The Secretary Gerhard Scheuriker and the Treasurer Alan Armstrong ascertain that 12 of the attendant members have voting rights in this GA.

At the time of the GA the KSKA had 123 paid members (Figures of the Treasurer Alan Armstrong).

A3: Report of the President

Pascal Petrella made a short overview of the activities of the KSKA since the last GA in Valencia. He mentioned the AKI-Gasshuku in Berlin and the special instructor course in Eggberge (Switzerland).

He stated that the Aki-Gasshuku 2009 in Oktober will be in Loutraki Greece, and the next Natsu-Gasshuku in May will be in Portugal.

Regarding the current statutes Mr. Petrella mentioned, that due to lack of participation, the GA is not quorate because a minimum amount of ¼ of KSKA members must be present.

Due to a lack of practicability, a change of the statutes is absolutely necessary, in order to have statutes which reflects the international status of our organisation.

For example, Mr. Drousolakis, the former Secretary resigned from his position due to personal reasons. In the current statutes the void position can only be filled by the GA. Since this assembly is not quorate, the position is still void (in theory). Hence the statutes have to be changed in a way that the EC is able to work.

The change of the statues is on the agenda of this GA.

Mr. Petrella thanked for the attention and passed the word to the Secretary.

A4: Report of the Secretary

Gerhard Scheuriker introduces himself. He agreed to do the job as a secretary from Spiros Droussoulakis who resigned in February 2009. He wills interim do the job until a proper voting of a general assembly will be possible.

In his report he stated that the KSKA has currently 123 members. 21 of them are provisional member. There are 17 persons which did not paid till now there member fee. They will be contacted by the secretary. If everybody has paid their fees, we should have 140 members.

The Secretary gave after a short report of the tasks he has done up to this meeting.

The first point was information about the new official KSKA Homepage address:

www.ksk-academy.org

He explains that on this site all information about the KSKA, the activities will be displayed. A member info which will be send monthly by email, will inform about changes on the website.

The second project which is nearly finished is a database about all members of the KSKA. It will be based on a server from which the Shihankai and the EC can have the overview about the situation of members and interested parties.

Another point was that it will be soon possible for persons who are interested in our activities can registries themselves with their personal email address at our Homepage. They will receive than our Newsletter which informs about the latest activities. Hence we can provide soon a valuable tool to spread e.g. information about stages, report of stages, or any change of the KSKA Homepage.

Mr. Scheuriker informed also about the **new application regulations**. Applicants for KSKA membership **can apply directly to the KSKA Secretary**. He will forward the application to the Shihankai for approval.

The new applications will only be accepted if all necessary information's are given, an attached picture and a copy of the latest Dan certificate. Application for KSKA membership can be handed in to the Secretary during the whole year, and it will be processed immediately. The application process is faster if the applicant is supported by a Shihankai member.

In order to update the new database, the secretary would like to ask all members to send him a picture.
